The EQUATOR Network – background information

The EQUATOR (Enhancing the Quality and Transparency of Health Research) Network is an international initiative that seeks to improve the reliability and value of published health research literature by promoting transparent and accurate reporting and wider use of robust reporting guidelines. It is the first coordinated attempt to tackle the problems of inadequate reporting systematically and on a global scale; it advances the work done by individual groups over the last 15 years.

The Network has **seven major goals**:

- Develop and maintain a comprehensive online resource centre providing up-to-date information, tools and other materials related to health research reporting (Library for Health Research Reporting)
- Assist in the development, dissemination and implementation of robust reporting guidelines
- Actively promote the use of reporting guidelines and good research reporting practices through an education and training programme
- Support journals in implementing reporting guidelines and conduct regular assessments of how journals use these guidelines
- Conduct regular audits of reporting quality across the health research literature
- Set up a global network of local EQUATOR centres to facilitate the improvement of health research reporting on a worldwide scale
- Develop a general strategy for translating principles of responsible research reporting into practice

Key deliverables of the EQUATOR programme include:

- Online resources facilitating good reporting practice
- Education and training programme supporting good reporting
- Global network of local EQUATOR centres raising standards in health research conduct and reporting on a local (national) level



The EQUATOR Network was officially launched in June 2008. Since its launch, the programme has already achieved **important milestones**:

- Developed a free online Library for health research reporting (<http://www.equator-network.org/>)
- In collaboration with the Pan American Health Organisation (PAHO) launched the Spanish version of the EQUATOR website and signed a three year memorandum on mutual collaboration in promoting responsible research reporting in PAHO South American and Caribbean regions (<http://www.espanol.equator-network.org/>)
- Built international recognition and reputation as the leading authority and resource portal in the area of health research reporting. Reference to EQUATOR is included in the "Recommendations for the Conduct, Reporting, Editing, and Publication of Scholarly Work in Medical Journals" (formerly Uniform Requirements for Biomedical Manuscripts), the most fundamental guidelines developed by the International Committee of Medical Journal Editors (ICMJE) that are followed by most biomedical journals
- Organised workshops, seminars, talks and Annual Lectures on issues relevant to research reporting
- Published a number of research papers and articles promoting good research reporting; published a regular online newsletter and set up a LinkedIn group disseminating information about new reporting guidelines and the latest developments
